This is to inform you that the selection trials of Indian Cycling Team is scheduled to be held at Gohana, Haryana on 5<sup>th</sup> Jan. 2025 to select Indian Cycling team for the forthcoming Asian Road Cycling Championships scheduled from 6<sup>th</sup> to 16<sup>th</sup> Feb. 2025 at Bangkok, Thailand.

The trials will be conducted for the Men U 23, Women Elite, Men Junior & Women Junior categories as per the details given below:-

Cyclists who had obtained rank 10<sup>th</sup> place in Time Trial & Road Race event at recently held National Road Cycling Championships at Puri, Bhubaneshwar, Odisha, are eligible to take part in the above-mentioned selection trials.

In case, those who are not falling under this eligibility, can also participate in the trials by depositing a fee of Rs. 2,000/-, which will be refundable, if he/she ranked within 10<sup>th</sup> in the said trials.
