Dear Sir/ Madam.

Greetings from Cycling Federation of India!

This is to inform you that HCL in association with Cycling Federation of India is organizing HCL Cyclothon Noida edition on 23rd March 2025. 50 Km. Criterium event for Elite Men and 40 Km. Elite Women (age between 18-40 years) will be held on a circuit. Prize Money of Rs. 15 Lakh (Inclusive of necessary Income Tax deduction as applicable) will be awarded to the winners up to 10th Position in Elite Men & Women category as well as team position upto 3rd.

Kindly note that selected 50 Cyclists (30 male & 20 female) will be eligible to get lodging/ Boarding and local transportation along with to and fro sleeper class train fare. Accommodation will be provided on 22nd & 23rd March 2025 (Check out on 23rd March 2025 afternoon). The selection of the 50 Cyclists (30 Male & 20 Female) will be held on the basis of their current National ranking.

Further, other than the selected Cyclists, any other rider who wish to participate in the said Cyclothon event, can participate at their own expenses i.e. boarding, lodging & transportation. No boarding, lodging & local transport will be provided by the organizer. The entries shall be accepted from the official email of the state associations/units and only for the licensed riders only.

List of 50 Cyclists (30 Male & 20 Female) will be circulated once the Entries received from the state associations/boards.

You are requested to forward the entries of riders & officials of your State/Board to the Cycling Federation of India by 1700 Hrs. 12th March 2025.

Note:- It has been noticed that in previous events, entries are confirmed by State Associations but many Cyclists don't report for the event. This has become a serious issue for the organizers and in view of the above, the state/board shall be penalised Rs. 1000/- per entry for not reporting at the event and in addition the rider shall be barred for the next one event.
