Circular of HCL Cyclothon, Hyderabad on 9th Nov. 2025

Dear Sir/ Madam,

Greetings from Cycling Federation of India!

This is to inform you that HCL in association with Cycling Federation of India is organizing HCL Cyclothon Hyderabad Edition on 9<sup>th</sup> Nov. 2025 at Prime Arena, Hyderabad. 48 Km. Criterium Race event for Elite Men and Elite Women will be held. The Prize money details will be shared in due course.

Kindly note that selected 50 Cyclists (30 male & 20 female) will be eligible to get lodging/ Boarding along with to and fro sleeper class train fare. Accommodation will be provided on 8<sup>th</sup> & 9<sup>th</sup> Nov. 2025 (Check out on 10<sup>th</sup> Nov 2025 morning). The selection of the 50 Cyclists (30 Male & 20 Female) will be on the basis of their National ranking.

Further, other than the selected Cyclists, other riders who wish to participate in the said Cyclothon event, can participate at their own expenses i.e. boarding, lodging. No boarding, lodging will be provided by the organizer. The entries shall be accepted from the official email of the state associations/units and only for the licensed riders only.

List of 50 Cyclists (30 Male & 20 Female) will be circulated once the Entries received from the state associations/boards.

You are requested to forward the entries of riders & officials of your State/Board to Cycling Federation of India latest by 1700 Hrs. 30<sup>th</sup> Oct. 2025. Guidelines of Rider License along with New Rider License form is enclosed as Annexure I & II.

Note:- It has been noticed that in previous events, entries are confirmed by State Associations but many Cyclists don't report for the event. This has become a serious issue for the organizers and in view of the above, the state/board shall be penalized Rs. 1000/- per entry for not reporting at the event and in addition the rider shall be barred for the next two event.

Also, a list of the riders, who did not report after the confirmation of entries, shall not be considered for this event. List of these riders are enclosed.
