Greetings from Cycling Federation of India!

This is to inform you that **HCL in association with Cycling Federation of India is organizing HCL Cyclothon Chennai Edition on 11th Oct, 2026 50 Km. Road Race (Mass Start) (subject to change) event for Elite Men and Elite Women** (age between 18-40 years) will be held on a circuit. **The Prize money details will be shared in due course.**

Kindly note that selected **50 Cyclists (30 male & 20 female)** will be eligible to get lodging/boarding and local transportation along with to and fro sleeper class train fare. Accommodation will be provided on **10th & 11th Oct** (Check out on 11th Oct). The selection of the 50 Cyclists (30 Male & 20 Female) will be on the basis of their ranking in the last National Road Cycling Championships held at Sambalpur, Odisha.

Further, other than the selected Cyclists, other riders who wish to participate in the said Cyclothon event, can participate at their own expenses i.e. boarding, lodging & transportation. No boarding, lodging & local transport will be provided by the organizer. The entries shall be accepted from the official email of the state associations/units and only for the licensed riders only.

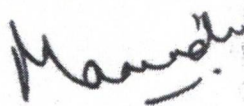
